## United Sovereign Americans Sues For Valid Elections

Press Release

Summary of Petition Filed June 18, 2024 in United States District Court of the Middle District of Pennsylvania, Harrisburg, Pennsylvania

Petitioners' argument is simple: Congress has outlined the minimum standards which must be maintained by every state in order for a federal election to be considered reliable. In Pennsylvania's 2022 federal election, those minimum standards were not met thus producing unreliable results that should not have been certified. Without the Court's action, the 2024 (and subsequent) federal elections will also be unreliable.

Commonwealth officials must conform to certain laws to properly conduct a federal election. The Help America Vote Act (HAVA) is one of those laws and exists in part to "establish minimum election administration standards for States and units of local government ..." 52 US.C.A. 21083. HAVA requires that voter roll databases contain only the registrations of qualified citizen voters residing in that state. 52 US.C.A. 21083(a). HAVA further defines a voting system as "the total combination of mechanical, electromechanical, or electronic equipment (including software, firmware, and documentation required to program, control, and support the equipment) that is used to define ballots; to cast and count votes; to report or display election results; and to maintain and produce any audit trail information." 52 US.C.A. 21083. Voter registration is thus encompassed in the definition of a voting system defined in HAVA because a voting system includes the documentation required to program the voting machines and to "cast and count votes." 52 US.C.A. 21081(b). Petitioners believe the ability to "cast and count votes" begins with establishing eligibility and registering only qualified citizens into voter registration databases, thus assuring that all ballots distributed, cast, and counted, are lawful. As voter registration is included as part of the voting system, it is subject to the allowable or not allowable error rates of voting systems set forth in HAVA.

Analysis of the official Pennsylvania State Voter Registration Data for the 2022 election revealed that, out of 8,755,458 voter registrations, there was a total of 3,192,069 voter registration violations. Out of the votes cast in the 2022 general election, there were a total of 1,198,598 evident voting violations, and 1,089,750 unique votes impacted by these apparent voting violations. The total number of Unique Ballots impacted by voting system errors was 1,089,706. Under HAVA, an error rate of no more than one in 125,000 ballots is permissible before the results of the entire election become suspect, and the integrity and reliability of the election compromised. For the 2022 general election the calculated rate was a maximum of 44 errors permitted or 0.0008%. The registration error rate in Pennsylvania for the 2022 General Election was thirty-two percent (32%). The vote error rate in Pennsylvania for the 2022 General Election was twenty percent (20%).

Additionally, the official canvas for the 2022 Pennsylvania Election was 5,410,022 votes (ballots counted) yet there exist only 5,400,869 voters who actually voted according to the data provided – a discrepancy of 9,153 votes that are totally unaccounted for and unexplainable.

Petitioners' purpose in setting forth the errors in the 2022 election is to demonstrate the Commonwealth does not have effective control over a voting system that is in conformity with federal and state requirements. The Commonwealth has implemented a system that does not guarantee accuracy or compliance with legal mandates. Petitioners seek redress from these voter registration apparent errors, relief from discrepancies between votes cast and actual votes reported, and relief from voting errors generally, which collectively and historically amount to violations of federal election laws, Pennsylvania election laws, and various voting rights encompassed by the United States Constitution and civil rights statutes.

Petitioners have brought this issue to the attention of Respondents, who have failed to address these errors ensuring future elections will suffer from the same deficiencies. The Respondents' collective actions in refusing to address the problem extinguishes and undermines the very meaning of the right to vote in a fair democracy.

To be clear, Petitioners do not challenge the outcome of the 2022 election. Discussions and/or litigation in Pennsylvania, as well as in other states around the Nation, centered on whether raw vote totals were accurate, with particular attention focused on the question: "if all ballots in dispute were decided, hypothetically, in the favor of one candidate for president in 2020 over the other, would that have changed the outcome of the election in that state?"

Petitioners posit a different question: How many disputed ballots found to be improperly cast in any given federal election may occur before the reliability and integrity of the entire election becomes suspect? Petitioners respectfully represent that Congress has already answered this very question.

The relief requested by Petitioners in the form of a Writ of

Mandamus seeks the Court to order Respondents to perform the ministerial functions their jobs require by taking actions to rectify issues with the 2022 election and bring the 2024 (and subsequent) federal elections supervised by Pennsylvania authorities, into conformity with the minimum standards for reliability set down by Congress.

Respondents must address issues with compliance to existing election law, specifically: be compelled to adequately investigate the issues, prosecute anyone in violation of federal and/or state law, and actively work to bring the Commonwealth back into compliance with federal and state election law mandates so that Pennsylvania's voters right to vote is upheld.

# Report From The State Republican Central Committee Convention

Beginning on June 27th and ending on June 29th, 2024 the Montana Republican Party held their State Central Committee Convention in Billings which brought together the four voting officers of all the Republican Central Committees across the state along with inviting every Republican member of the State Congress.

Friday was dedicated to the voting central committee representatives (the Chair, the State committee man and woman and the Finance Chair) and the State Congressional representatives assigned to the various committees dedicated to reviewing and suggesting amendments to the "planks" that make up the State Republican Platform. The platform constitutes the core values of the Montana Republican Party and therefore defines what a Montana Republican is, or SHOULD be. Each plank in the platform was reviewed by these committees and most had amendments to them offered.

Saturday morning began the conclusion of the conference. First on the agenda was the review of the amendments to the rules, or By-laws, that govern the administration of the party. These amendments were voted on by the official representatives of the Central Committees; the Chair, the State Committeeman and Committeewoman and the Finance Chair. All but one of the amendments offered were adopted.

Next was the review of the amendments to the party platform produced by the various plank committees on Friday. The plank amendments are voted on by both the Central Committee Representatives and the congressional contingent. The first offered was a resolution proclaiming the Montana Republican Party opposes any and all forms of Ranked Choice voting. After this resolution was adopted, voting turned to the platform planks. Following are some highlights of the changes adopted throughout the convention: of Constitutional rights of all people.

**Business and Labor:** The MTGOP officially opposes the government picking winners and losers in the free market

**Crime now Law & Justice:** The MTGOP proclaims Crime is having a devastating effect on our communities and calls for accountability and punishment for criminals.

Economic Development: The MTGOP encourages the Montana judiciary to stop restricting economic development by legislating from the bench.

**K-12 Education:** The MTGOP supports moving school board elections to concur with primary or general elections.

**Election Law:** The MTGOP calls for all digital records generated by electronic voting machines to be deemed "election records" and public records to be preserved for 72 months. In addition the MTGOP fully supports vetting of all candidates at the precinct level, and endorses that all citizens are responsible for monitoring any and all elections for fraud and calls on the State AG to file suit against any State that violates Federal election law.

Human Services: The MTGOP maintains marriage is between one man and one woman and stands against warrantless seizure of any child except in cases where bodily harm is imminent.

**Immigration:** The MTGOP supports deportation of illegals in Montana, the use of E-Verify to prevent hiring of illegals, absolute refusal of accepting any illegals into Montana, the loss of non-profit status of any person, non-profit entity or NGO that participates in aid and abetting illegals entering Montana and any such activity shall be subject to human trafficking criminal charges. digital currency.

**Natural Resources:** The MTGOP now opposes the relocation into Montana of Bison from places like Yellowstone National Park.

The full Republican platform is currently under scrutiny for grammatical and syntax corrections.

**Agriculture:** The MTGOP now officially opposes the lease, sale or rental of agricultural land to any foreign adversaries or corporations headquartered there. Also, the MTGOP now officially supports the ban of lab-grown meat and are against the labeling of plant-based products as "meat".

**American Indian Affairs:** The MTGOP agreed to facilitate mutual cooperation with American Indian tribes and all Montana citizens to insure the protection Local Government: The MTGOP supports local governments to partner with constituents by allowing a vote for all tax increases at the general election and proclaims that local government shall protect property rights National Affairs: The MTGOP confirms they stand against any and all encroachment on citizens Constitutional rights and Montana State powers and confirms to maintain the right of nullification Federal laws that would infringe on those rights. # Inside The Ravalli County Republican Central Committee

The primary election allowed citizens to elect people to represent them on the Ravalli County Republican Central Committee (RCRCC). This primary saw more candidates for these positions than at any other time in recent memory and possibly history in Ravalli County. Ravalli residents are wondering: Why are these positions so highly contested? The answer to that question is fairly simple, yet, not easily explained. As one that lived it, I will attempt that explanation. To grasp the current status, one must first understand the recent past.

In the summer of 2022 the MTGOP (Montana Grand-Old-Party) adopted a rule change that was in direct violation of state law, moving the county leadership elections for Republican Central Committees (RCCs) to AFTER the State Party leadership elections. This new rule effected all county RCCs across the state. In the early spring of 2023 the RCRCC notified the MTGOP of this violation of state law. In response to this notice the MTGOP issued an email distributed to all RCC chairs in the state citing an anonymous legal opinion claiming that the MTGOP was NOT in violation of state law. The party moved ahead with their determined plan to hold their leadership convention in the summer of 2023. The RCRCC (and a few other counties) held their county leadership convention in compliance with state law and in protest to the new MTGOP "rule".

During the 2023 legislative session House Bill 322 was drafted and adopted. This bill confirmed the RCRCC had indeed correctly interpreted the law and the MTGOP's "legal opinion" was flat wrong. HB322, clearly confirming the MTGOP was knowingly operating in violation of standing state law, was signed into law by the Governor on May 18th, 2023, a full three weeks before the MTGOP Leadership Convention held in Missoula June 9 & 10, 2023. In spite of being notified they were breaking the law, the MTGOP forged ahead with their planned leadership convention. The RCRCC brought all this information to the attention of the MTGOP at this convention and protested the credentialing of the displaced RCRCC leadership. As anticipated, the MTGOP-assigned credentialing committee ruled against the new lawfully elected RCRCC leadership, thereby guaranteeing the existing MTGOP leadership would continue through the

MTGOP leadership seems to be the attitude exhibited by most elements of Government today, that of: "**If you don't like it, Sue Me!**"

Subsequently, in order to be "recognized as official" and gain voting rights within the MTGOP, by the now illegitimate MTGOP, county RCCs were forced by the MTGOP to violate state law by holding unlawful leadership conventions in the fall. The illegitimate legacy leaderships of various (I.E. Missoula and Ravalli) county RCCs delayed holding the 2023 leadership elections until the last minute allowed by the MTGOP rule, the end of October. This spiteful act caused the new RCC's leadership terms to be shortened by over 6 months. It is worth noting here that at the time of the leadership change, displacing Mr. Nelson as Chair of the RCRCC, a number of incumbent precinct representatives resigned and many others boycotted the RCRCC meetings by refusing to attend under the newly elected leaders.

Now to the crux of the issue of why the **Republican Precinct representative** positions were so highly contested. The former Chair of the RCRCC, Terry Nelson, who had held the Chair position of the RCRCC for over 13 years, lost his position as Chair in October 2023. Nelson is now Secretary of the MTGOP, being elected at the illegal convention, yet, Nelson seems to be seeking to regain his position as Chair of the RCRCC. Evidence shows that Mr. Nelson and his loyalists, recruited candidates to seek election to the RCRCC throughout the county. Most all of these candidates submitted their candidacy on the last allowable filing date. Evidence also shows that loyalty to Mr. Nelson, and his agenda, was a primary qualification to earn the endorsement and support of Mr. Nelson. Rather than any allegiance to Republican principles or the Montana Republican Party Platform. That evidence was confirmed at the most recent RCRCC meeting held July 2nd, where all precinct representatives were given the oath-of-office. It is an established policy of the RCRCC that allegiance to the State Republican Platform be confirmed by ALL Republican precinct representatives at the swearing in ceremony for obvious reasons.

It is the primary goal and purpose of *Truth* Be Told News to provide readers with the Truth, substantiated by facts. These individuals registered and ran as "Republicans" to <u>represent you</u> at your Precinct as Republicans, yet, have taken extraordinary efforts to avoid proclaiming allegiance to the Montana Republican Party Platform. In the business world this would be grounds for an investigation of fraud. Unfortunately, there are no such laws governing politics, yet this does leave one to wonder what party's platform do these folks represent? First, of course, the open primary system that allows anyone to register for any party they believe will help them win, and second, having the "State" involved in the administration of private political parties, as they have been declared by SCOTUS. Imagine having the same state involvement in the Elks, the Eagles, the VFW, the 4-H or any other private organization. To have "the state" mandating how their representatives and leadership are elected is as bizarre as it sounds. It's only accepted in politics because now it's "the norm".

## Idaho Non-Citizen Voters

BOISE - Idaho Governor Brad Little and Secretary of State Phil McGrane announced Tuesday morning that Idaho is the first state to take executive action to ensure Idaho's voter rolls remain free of non-citizens.

Governor Little signed Executive Order 2024-07, the Only Citizens Will Vote Act. Little's office says it will protect election integrity, voter confidence, and the sanctity of voting. "Idaho already has the most secure elections in the nation, and we're going to keep it that way. My executive order – the Only Citizens Will Vote Act - directs Secretary of State Phil McGrane to work with local county clerks to scrub our voter rolls and make sure Idaho's elections do not fall prey to the consequences of Biden's lawless open border," Governor Little said.

"Across Idaho's 44 counties, we have excellent mechanisms in place already to ensure noncitizens do not vote in Idaho, but there is always more we can do to make sure only citizens will vote. I am proud to work closely with Governor Brad Little to put in place a plan that keeps Idaho ahead of the pack in election integrity," Secretary McGrane said.

Little and McGrane say states in the eastern U.S. and the Biden Administration have eroded confidence in elections by seeking to register non-citizens to vote. "Idaho is fighting back to keep our voter rolls free of non-citizens, a step that is especially important as more and more people pour across our lawless open southern border illegally," said a statement from Little's Office.

The order directs the following actions:

The Secretary of State shall immediately take all necessary steps to ensure that processes are in place to validate voter registration and prevent non-citizens from registering to vote.

The Secretary of State shall routinely review Idaho's voter rolls, in coordination with Idaho State Police and the Idaho Transportation Department, to identify any potential noncitizens.

The Secretary of State shall coordinate with the U.S. Department of Homeland Security and take any steps necessary to verify citizenship status to ensure no non-citizens are participating in Idaho elections.

Per SCOTUS Blog "Justice Roberts rejected any suggestion that agencies, rather than courts, are better suited to determine what ambiguities in a federal law might mean. Even when those ambiguities involve technical or scientific questions that fall within an agency's area of expertise."

#### The Recent 9th Circuit Ruling Will Not Be Overruled.

Today's Supreme Court ruling supports the recent 9th Circuit Court of Appeals ruling that plaintiffs can challenge the US government's claim that the COVID-19 injections are "safe and effective vaccines" and seek compensatory damage in court. The judges ruled that a defendant cannot claim that the mRNA injections are "safe and effective vaccines," just because the FDA and CDC said so.

The expert opinion of a government agency, such as the CDC, that goes against an overwhelming body of evidence (from the CDC) has no bearing in a Constitutional court of law.

The "Purpose" of Government in the United States having been established in the previous issue, this article will address how we reached the point of being servants to government rather than government serving us to secure our rights? That story is a long and sad saga. Many rights reserved for The People have been stolen from us. Some in the dark-of-night, some in the full light of day and some while the people were celebrating favorite holidays. As most of these abridgments are semi-ancient history, we will focus on some of the most recent.

With any deconstruction project, where the desire is to preserve the foundation, it is required to carefully remove the unwanted parts. It is logical to start this process with the most recently added parts on top. That process took a very significant step in the last week of June, 2024.

June 29, 2024: In a 6-3 ruling, the Supreme Court of the United States (SCOTUS) overruled the 1984 case Chevron vs. Natural Resources, which became known as Chevron deference. Chevron deference requires courts to defer to experts from government agencies, such as the IRS, FBI, CIA, FDA, BATF, CDC, HHS, and NIH, to interpret the 'ambiguities of the laws' that govern those agencies and the corporations and public policies they regulate.

In Justice Thomas' concurring opinion, he wrote;

#### "Chevron deference was 'not a harmless transfer of power.'

The Constitution carefully imposes structural constraints on all three branches, and the exercise of power free of those accompanying restraints subverts the design of the Constitution's ratifiers,' In particular, the Founders envisioned that "the courts would check the Executive by applying the correct interpretation of the law."

Chevron was thus a fundamental disruption of our separation of powers. It improperly strips courts of judicial power by simultaneously increasing the power of executive agencies. By overruling Chevron, we restore this aspect of our separation of powers. To safeguard individual liberty, "structure is everything." Although the Court finally ends our 40-year misadventure with Chevron deference, its more profound problems should not be overlooked. Regardless of what a statute says, the type of deference required by Chevron violates the Constitution.

In the annual report to the Governor and Legislature regarding voter registration maintenance, pursuant to Idaho Code 34-418(2), the Secretary of State and county clerks shall report on their efforts to prevent and remove non-citizens from Idaho's voter rolls.

State agencies shall not provide voter registration materials to non-citizens or coordinate with any federal programs or agencies to provide voter registration material to non-citizens in the State of Idaho.

State agencies entering into or renewing contracts with federal agencies or partners must confirm there is no requirement to provide voter registration materials to noncitizens or otherwise requiring voter registration activities for non-citizens.

#### The Tables Have Flipped

In her dissenting opinion, Justice Kagan wrote, "Today, the Supreme Court flips the script: It is now the courts (rather than the agency) that will wield power when Congress has left an area of interpretive discretion."

Yes, Justice Kagan. The tables of justice have just flipped; against the hostile takeover of our nation by the 3-letter agencies and in favor of the American people and our children.

This ruling is a HUGE step in reining in an out-of-control regulatory branch of unconstitutional government powers. SCOTUS should be applauded.

## GMOs What are GMOs and what do we need to know about them?

# GMOs stand for Genetically Modified (Engineered) Organisms.

#### How are they made?

They are created by transferring genes of one species and forcing them into the DNA of another like corn or soybeans with gene guns. 1. They literally put millions of the desired gene into a gun that coats tungsten or gold particles. Then they blast those into a plate of cells hoping that some of those genes make it into the DNA of some of those cells. Then they clone those cells so that each and every cell of that crop contains the altered gene. 2. They use bacteria to infect the cell, carrying the gene with it.

Or with gene editing equipment which rearranges genes in the sequence, takes genes out, etc. It's all artificial changes in the DNA done in a laboratory. All of it produces massive collateral damage in the DNA.

#### Why were they created?

First of all you need to understand who is making these technologies and the food that is a product of this technology. The corporate giants are Monsanto, Bayer (a pharmaceutical giant who bought Monsanto), Syngenta, Dow, and Dupont. All are chemical companies that are in charge of most of our food supply! According to the Manufacturers Association (GMA) 80 percent of the foods on your grocery store's shelves contain GMOs (now referred to as GEs by the FDA) but virtually none of them are labeled.

As concern about pesticides toxicity and other potential health hazards associated with GE foods grow, more and more people want to know what's in the food they buy. According to a December 2015 poll, 9 out of 10 Americans now want mandatory labeling for GE (GMOs) foods.

#### What Motivates These People?

So, what was the motivation to corrupt our food supply through this technology. Monsanto is a big GMO producer, and they sell Roundup herbicide. They had a patent on glyphosate-the chief poison (but not the most dangerous ingredient) in Roundupthat was expiring in the year 2000. So, they genetically engineered crops to withstand the herbicide Roundup. These are called Roundup-ready crops, and they comprise 80% of all GMOs. They are engineered so that farmers can spray Roundup over the top of the field of corn or soy, and it will kill the weeds but not the crops. Normally the Roundup would kill those crops, but the Roundup-ready crops survive.

#### Are they safe?

In 2015, dozens of food, farming, and environmental justice groups announced they will put Monsanto on trial for "crimes against nature and humanity" on October 16, 2016 (World Food Day) in the Hague, Netherlands, found Monsanto guilty. As noted by Andre Leu, president of the International Foundation for Organic Agriculture (IFOAM), "Monsanto is able to ignore the human and environmental damage caused by its products, and maintain its devastating activities through a strategy of systemic concealment: By lobbying regulatory agencies and governments, by resorting to lying and corruption, by financing fraudulent scientific studies, by pressuring independent scientists and by manipulating the press and media. Monsanto's history reads like a text-book case of impunity, benefitting transnational corporations and their executives, whose activities contribute to climate and biosphere crises and threaten the safety of the planet."

#### Who oversees the safety studies?

According to Jeffrey Smith author of the world's bestselling book on GMOS, Seeds of Deception, and founder of Institute for Responsible Technology "Monsanto and the FDA have been covering up the health dangers of GMOs for years. Their fraud has been the basis of allowing this catastrophe to take place in our food supply and our environment, The person in charge of policy at the FDA that gave GMOs a free pass was Michael Taylor, a former attorney to Monsanto and later Monsanto's vice president. He said "We don't see any significant differences between GMOs and non-GMOs." Therefore, no testing is necessary, no labeling is necessary, and companies like Monsanto can determine on their own if their GMOs are safe, and even tell the FDA if they want to put it on the market. He'd been given a job in the FDA created for him after the first Bush Administration White House instructed the FDA to promote GMO's. Everyone in government and everyone that listens to the FDA says "GMOs are no different. They're the same." When you look at the documents that were actually circulating among the scientists and leaders of the FDA at the time, it turns out the overwhelming consensus among the scientists working at the agency was exactly the opposite. That GMOs were different, dangerous, could lead to allergens, toxins, new diseases, nutritional problems, and that they deserve in-depth studies, including human toxicological studies, that were never done and never required."

Are there health risks to eating GMOs? In the next installment on this topic, I will go into the numerous and devastating health effects of consuming GMO products and eating animals that were fed these



To clearly display this breach of contract we can look to Art 4, Sec. 4 of the US Constitution that says,

*"The United States shall guarantee to every"* State in this Union a Republican Form of Government, and shall protect each of them against Invasion; and on Application of the Legislature, or the Executive (when the legislature cannot be convened) against domestic Violence."

Words like "guarantee," "Republican form," and "against Invasion," should stick out. When two parties are signatories to a contract and one of them fails to follow the terms, they are in breach of contract and subject to penalties. In this case the penalty is a simple statement of "no," to all measures that do not conform to the principle of constitutional governance.

How many of our states have the courage to act?


people have been reporting on the damage caused by these shots on humans, backed by evidence.
